### Minimum scope of care

Two full days – equivalent to 40% care per week. Full days only.

### Supplementary Charges

- Initial and Administrative charge: An initial non-refundable charge of CHF 150.00 is due. Usage of two entry badges for the day-care center is included in this charge.
- Extra entry badges: CHF 40.00 per entry badge (to be paid in cash in the center). The same amount will be charged in case of loss.
- Supplementary care: Supplementary days are possible when availability in the center permits and should be agreed with the day-care center directly.

### Payment Conditions

The invoice is **to be paid in advance** and is due at the latest **on the first day of the month of care**.

In the case of arrears, the conditions stipulated in the fee regulations apply.

### Contract Termination Period

The notice period for terminating the contract is two months and is binding for both parties. Cancellation is possible at the month's end. Notice of termination must be made in writing, either by e-mail or letter. The two months' notice period is also valid when the number of care days is reduced as well as if the child moves to another of KiBiZ's institutions (another KiBiZ day-care center or the KiBiZ childminders). Please refer to the Fee Regulations.

### Childcare Vouchers

- Parents/legal guardians resident in the City of Zug** may be eligible for childcare vouchers for day-care. The voucher amount depends on taxable income and taxable assets. Payment into 3A savings and into pension funds are added to these. All information can be found on the City of Zug webpage: <https://www.stadtzug.ch/betreuungsgutscheine>.
